Head boy becomes CEO

P&G'S NEW CORNER OFFICE OCCUPANT WILL STEER THE FIRM THROUGH A DIFFICULT PERIOD

SHAILESH JEJURIKAR, Procter & Gamble's incoming president & CEO, learnt important lessons in leadership as head boy of his school in Hyderabad in the early 1980s. Giving a patient ear to classmates and teachers as a senior prefect, leading by example rather than rules, and devoting time to both study and play (he was an avid cricketer as well as a bright student) were key takeaways that Jejurikar would apply later in life.

As the IIM-Lucknow alumnus gears up to lead a 187-year-old American company — the first Asian and Indian to do so — he will need to draw upon his varied learnings. Jejurikar, whose world view has been shaped by degrees in liberal economics and management, is also among the few chief executives in America Inc, whose education has been entirely in India. His success, say industry executives, has been achieved by dint of hard work, curiosity and passion as he worked his way up the corporate ladder over 36 years in P&G. "When you unlock an insight with curiosity, the power to drive limitless growth is huge," he said in a P&GAlumni Podcast in 2023.

The Cincinnati-based P&G is going through a difficult period at the moment as it navigates tariff-related uncertainties as well as slowdown concerns. On Tuesday, even as Jejurikar's appointment was celebrated in his home country India, P&G

said that it would need to raise prices on a quarter of the goods it sells in the United States, its largest market, starting August. That is expected to slow down sales even further for the global major, which cut its annual sales forecast for

Retail leasing in malls rises 69%: JLL

LEASING OF RETAIL spaces in shopping malls and high streets rose 69% to 5.7 million sqft in the January-June period across seven major cities on better demand from both domestic and foreign retailers, according to JLL India.

New supply of retail spaces more than doubles to 2.3 million sq ft during the first six months of this calendar year from 0.9 million sq ft in the corresponding period of 2024 across seven cities — Delhi-NCR, Bengaluru, Chennai, Hyderabad, Kolkata, Mumbai, and Pune, real estate consulJLL India projected that the leasing of retail spaces might cross 10 million sq ft in 2025

tant JLL India said in a statement on Wednesday.

"Interestingly, the first half of 2025 has already achieved 70% of last year's annual leasing volume, which stood at 8.1 million sq ft," it added.

JLL India projected that the leasing of retail spaces might cross 10 million sq ft in the 2025 calendar year, with 5.9

million sq ft of new supply expected to be operational in the second half of this year.

"India's strategic position for retail expansion is evidenced by international brand entry more than doubling year-on-year in H1 2025, driven by the perfect confluence of young demographics, rising disposable incomes, and premium consumption preferences that are particularly attractive in the current global economic landscape," said



Indo-US space pact

takes flight with

success of NISAR

ISRO's launch vehicle GSLV-F16 carrying the NISAR earth observation satellite lifts off from the Satish Dhawan Space Centre, in Sriharikota, Andhra Pradesh, on Wednesday

S VIJAY KARTHIK Sriharikota (Andhra Pradesh), July 30

INDIA AND THE US on Wednesday marked their maiden space collaboration with the successful flight of a GSLV rocket that placed an earth observation satellite, jointly developed by the two space agencies, in a precise orbit.

ISRO's GSLV F-16 injected NISAR--NASA-ISRO Synthetic Aperture Radar satellite, into the intended Sun Synchronous Polar Orbit (SSPO), after a flight of about 19 minutes and around 745 km.

GSLV "successfully injected NISAR in designated orbit," ISRO said.

Wednesday's accomplishment follows the unsuccessful PSLV-C61/EOS-09 Mission on May 18, where a faulty PSLV of ISRO failed to deliver the earth observation satellite in the desired orbit.

After successfully launching similar satellites--Resources at and RISAT series which were operationally focused on India, ISRO through the NISAR mission is embarking on a journey to study planet Earth.

At the end of the 27.30 hour countdown, the 51.7 metre tall launch vehicle carrying the 2,393 kg satellite majestically lifted-off from the second launch pad at the Satish Dhawan Space Centre, here, situated about 135 km east of Chennai at a prefixed time of 5.40 pm on Wednes-

Post the separation from the rocket, the scientists would embark on commissioning the satellite which would take "several days" to position it and meet the mission objectives.

According to ISRO, the Sband Radar system, data handling and high-speed downlink system, the spacecraft and the launch system are developed by the national space agency. The L-band Radar system, high speed downlink system, the Solid State Recorder, GPS receiver, the 9m Boom hoisting the 12m reflector are delivered by NASA. —PTI



पुणे: खराडी येथील पार्टीवर पोलिसांनी छापा टाकल्याची संपूर्ण कारवाई संशयास्पद आहे. याबाबतचे चित्रीकरण, तसेच छायाचित्रे कोणी प्रसारित केली, याबाबबताच सखोल तपास व्हावा. अशी मागणी राष्ट्रवादी महिला काँग्रेसच्या (शरद पवार) प्रदेशाध्यक्ष रोहिणी खडसे यांनी बधवारी केली. खडसे यांनी पोलीस आयुक्त अमितेश कुमार यांची भेट घेतली. त्यांच्याकडे तक्रार अर्जही दिला.

टाकला, त्यावेळी पोलिसांनी तपासणी करण्यापर्वीच या तरुणींनी पर्समधील अमली पदार्थ काढ्न पोलिसांच्या हवाली करणे हे अतिशय संशयास्पद आहे. डॉ. खेवलकर यांचा मोबाइल संच पोलिसांच्या ताब्यात आहे. त्यातील छायाचित्रे आणि चित्रफीत जळगावमधील आमदाराने प्रसारित कशी केली. पहाटे चारच्या सुमारास डॉ. खेवलकर यांचे 'लोकेशन' कसे मिळाले.' असे प्रश्न खडसे यांनी उपस्थित केले.






